Dauntsey Guns Ltd gun storage policy T&Cs

1. Storage Charges

- Airguns are stored at a rate of **£5 per gun per week**.
- Shotguns are stored at a rate of **£5 per gun per week**.
- Section 1 Firearms are stored at a rate of **£5 per gun per week**.
- Section 5 are stored at a rate of **£10 per gun per week**.
- A week is defined as **any 7-day period or part of a 7-day period**.
- Storage charges begin on the date items are accepted into storage.

2. Storage Duration

- Items remain in storage until they are collected by the customer or an authorised suitably certified representative.
- The storage period ends on the date the items are released.

3. Payment Terms

- **All storage fees are payable at the end of the storage period**, prior to, or at the time of collection, no statements or interim invoices will be issued during the storage period unless agreed with the customer.
- Items **will not be released** until all outstanding charges are paid in full.
- We reserve the right to contact you if the storage fees become excessive. Under some circumstances, we may request part or full payment of the outstanding fee.
- Should you wish to sell your gun to cover all or some of the outstanding fees, Dauntsey Guns will assess the value of the guns you look to dispose of and deduct its current value from your storage bill based on our trade assessment.
- Storage fees are based on the rate outlined in this document. They are non-negotiable.

4. Non-Payment

- If payment is not made when the storage period ends, storage charges will continue to accrue at the agreed rate.
- If fees remain unpaid for **60 days after written notice** (by email or letter), we reserve the right to **sell or dispose of the stored items** to recover outstanding charges. Sale or disposal of your items will not take place without notifying the customer using the notification methods provided by the customer.
- It is the customers responsibility to inform Dauntsey Guns of any changes to their notification methods.
- Any proceeds from sale will be applied to storage fees and reasonable costs. Any remaining balance will be returned to the customer where possible.

5. Collection of Items

- Items may only be collected by the owner or an authorised person, the details of the authorised person must be notified in writing, the authorised person will need to be currently legally certified to possess the guns in order to collect.

All guns placed into storage should be clean and free of fouling as Dauntsey Guns will not be liable for any resultant degradation.

By placing your guns in storage with Dauntsey Guns Ltd, you are agreeing to our terms and conditions as specified herein.

v1.1 Revised 15/01/2026 to reflect price increase from £3 per gun per week. Price increases come into effect for new customers from 01/02/2026. Storage charges quoted for guns booked in prior to 01/02/2026 will stand for an additional month, before changing to the new £5 rate from 01/03/2026 unless the guns are collected or otherwise disposed of before this date.
